### **PRESIDENT'S REPORT**

It was an honour to be selected as President of the Board of Management of the Cerebral Palsy Support Network in 2011. I would first like to thank my fellow board members for their time and dedication to work through a number of difficult decisions over the past twelve months. This time has seen the CPSN grow into a position of strength to build for the future. The board is made up of people from both the Cerebral Palsy community and wider Victorian community who bring a diverse range of skills from business, academic research, strategic advisers and health professionals. They are all volunteers and are thanked for their effort in the last year.

In 2011 the board made a decision to return to the core business in servicing the direct needs of the CP community. It was from this review that we have been able to relaunch the brokerage program as "Cerebral Palsy Innovative Choices", commenced a new Social, Health and Recreation Program (SHARP) and started the Gym Goers program. Information Sessions have been offered and a variety of support groups continue to be offered around Melbourne. From this base the board has been able to work through a number of strategic areas that will focus on the CPSN community throughout Victoria in the next five years. We are excited to bring these new programs to the CPSN community as they are developed, including the redevelopment of the website which is in the planning stages now.

This year has also been an exciting year for the wider disability community with the announcement of the National Disability Insurance Scheme trial program to be run in the Barwon Region from 2013. As an organisation we will be closely watching this trial across Australia and will continue to advocate for its roll out to all people including our members in the near future.

On behalf of the board I would like to thank the Manager of the CPSN, Vicki Cavalieros for the tireless work she has completed and leadership she has show to her dedicated staff. The office has grown in the last year and with future projects to be delivered will continue to grow and change.

Finally I would like to thank all the volunteers who have helped throughout the year. Volunteers form a vital part of our team and ensure that we remain a viable and community based organisation.

## MANAGER'S REPORT

I wish to share with you some of the many changes and developments that the CPSN has seen over the last year. The last 12 months have been times of consolidation and reflect in placing the CPSN in a very healthy and viable position. We look forward to drawing upon all the lessons learned over the last year to assist us to move forward into a new year full of challenges and achievements. We also look forward to providing our members, our most valued assets, with ongoing support and information on Cerebral Palsy, continue to conduct and expand on our membership programs and introduce new initiatives which are based on membership feedback.

The CPSN has grown in all areas of service delivery which has been a direct result of new people joining our team both in the staffing and governance areas. I would like to farewell Amy Iscic who completed her administration traineeship and has moved onto pursue her career in this area, and of course a few board members who are mentioned further on in this report. I would like to welcome on board our new team of office staff: Melissa Flentjar who is our program's administrator, Rita Edwards our new bookkeeper and Mike McDermott who is our program's coordinator. I congratulate them for a job well done and thank them for their dedication and commitment to improving the lives of people with Cerebral Palsy and their families.

In November 2011, an application by the CPSN to become a registered service provider for Department of Human Services (DHS) was accepted by the Victorian State Government. This means that the CPSN are now recognised as a service provider who is compliant with all the State and Federal acts and laws, and all DHS and State Government guidelines and standards. This huge step forward will influence how we deliver our programs and services and will ensure that we are proactively implementing a quality service charter.

For many years now, in fact the entire reason for CPSN existing, was the benefit that peer support brings to families and individuals who are living with Cerebral Palsy. Over the years support groups have fluctuated in popularity among our members, however the CPSN believes this type of support, networking and sharing of information with others who have CP in common, is an integral part of the journey when living with Cerebral Palsy. Therefore we continue to offer these wonderful opportunities to our members. Support Groups (or coffee mornings) continue to meet monthly, and Information Sessions meeting bimonthly, often featuring guest speakers, meet in various locations across the Melbourne metropolitan regions.

CPSN traditionally holds an annual Family Fun Day to encourage the celebration of the end of the year and of course International Day of People with a Disability. These have gone from a small group of members meeting in the park for a picnic to becoming quite an event. The last few have seen a full day jam-packed with activates and performers, lunch and treats provided. These provide yet another opportunity for families to meet each other and socialise in a fun-filled, relaxed environment.

In keeping with its vision, the CPSN provides members with real and meaningful opportunities to enhance their lives. The Members Trust Fund was set up to meet this need. Since 2008 it has provided members with over 70 grants to purchase goods and services they may otherwise not have access to. This year we received 30 applications and we are proud to announce that we granted 20 applications valued at a total of \$9,169.

Last year our members brought to our attention that there was a lack of services for adults with CP in the area of maintaining personal fitness and strength training. We agreed that this is a vital part of staying healthy and fit. So, the CPSN, with financial assistance from a philanthropic trust fund and an anonymous donor, successfully commenced the Gym Goers Exercise Program. This program is conducted from two gyms and facilitates both group and individual sessions. We hope that the benefits of this trial program may provide further opportunities for the provision of more Gym Goers Programs in the future.

As well as our ongoing programs, the CPSN has been involved in various one-off events which have influenced the disability sector and raised awareness of Cerebral Palsy within our community. During 2011-12

the CPSN held a Disabili-Tea which was attended by our members in celebration of people with a disability; a Parents as Career Transition Support 3-day workshop in conjunction with Inner Northern Local Learning and Employment Network to prepare parents who's teens are transitioning out of secondary school; held a stall at the RIDE Expo in the South which showcased our organisation and the services we offer to members; delivered a range of presentations promoting CPSN and CP to other service providers including Case Management Action Group, Kids Plus, and Yooralla. We also held a stall at the Disability Sport and Recreation Expo which took place at Federation Square along with many other not-for-profit disability organisations, and attended, with our members, a very proactive rally in support of the National Disability Insurance Scheme.

In keeping up with the theme of 'change', CPSN implemented a few operational changes. Modern technology saw the implementation of more social media – for example, posts and events promoted on Facebook and Twitter, and emails alerts via our new membership database. This has allowed us to provide our members with instant information as it arrives hot off the press, thus reducing the need to sustain a lengthy bi-monthly 'What's the Buzz' newsletter. 'What's the Buzz' has also been given a new look and is now a very useful and effective monthly communication tool featuring all CPSN activities and promotion of CP awareness.

During this time, the CPSN also moved its office, not very far and only for short term, but none the less yet more change. Our team of dedicated staff worked very hard towards rehousing us and to ensure that the move caused our members little disruption. I would like to thank Gail Youni from Northern Support Services who came through with this great accommodation in a time of need.

As a not-for-profit organisation, we are constantly looking for ways to raise funds so that we are able to continue to provide our members with more. This year we have not focused so much on fundraising as we felt that developing membership services was a priority. We did however conduct a few smaller fundraising activities which we felt would engage our members, and of course raise some funds at the same time. Some of our fundraising activities included sales of the Kiddie Kutter Knives – safe cutlery for children, IT Reborn – cash for the collection of recycled computer and IT equipment, a tax time appeal to local businesses, and of course sales and promotion of the CPSN merchandise.

In addition to fundraising, the CPSN is able to hold some of its programs with the help of philanthropic trust funds. Throughout the year Jim Weber from Jim Weber Consultants has generously donated his time to assist with writing of submissions to attract this type of financial support. We thank him for his tireless efforts and look forward to continued support.

Perhaps the most significant change of all was the review of the CP Respite Brokerage Program as we know it. Late in 2011, as part of the strategic planning process, it became apparent that it was time to rejuvenate this program. It was also timely as the CPSN was now a recognised DHS service provider. A subcommittee was formed and off they went to work. The group dissected all areas of the program and started again. Old processes and guidelines were replaced by new ones and the program was given a whole new look and feel. CP Innovative Choices was born and launched at an Information Session in June 2012.

CP Innovative Choices works on the same principal and model as the Brokerage Program, however has added extra service options. The CPSN is very proud to offer this truly innovative program which we know enhances the lives of those with CP and their families. We look forward to offering this program to more of our members and the CP community.

As a forward-moving organisation, the CPSN is always looking at ways we can improve what we provide to our members. In this current time of growing technology, our website is an integral part of contact with our community. A new initiative will see the redevelopment of the CPSN website. A sub-committee has been established and is currently working on the re-design of a new site that will not only provide state of the art information on CP resources and services but will also act as a business tool, providing our members with easy access to online tools and resources at their fingertips. We look forward to presenting this new website and many other new initiatives in the next financial year.

Membership to CPSN is free to individuals with Cerebral Palsy and their family, also including grandparents and siblings.




#### **MEMBERS BY CATEGORY**

#### INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF CEREBRAL PALSY SUPPORT NETWORK INC.

#### REPORT ON THE FINANCIAL REPORT

We have audited the accompanying financial report, being a special purpose financial report, of Cerebral palsy Support Network Inc., which comprises the assets and liabilities statement as at 30 June 2012, and the income and expenditure statement for the year then ended a summary of significant accounting policies, other explanatory notes and the statement by members of the committee.

# Committee's Responsibility for the Financial Report

The committee of the association is responsible for the preparation and fair presentation of the financial report and has determined that the accounting policies described in note 1 to the financial statement, which form part of the financial report, are appropriate to meet the requirements of the Associations Incorporation Act 1981 (Vic) and are appropriate to meet the needs of the members. The committee's responsibilities also include establishing and maintaining internal control as the committee determines is the necessary to enable the preparation and fair presentation of the financial report that is free from material misstatement, whether due the fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

#### Auditor's Responsibility

Our responsibility is to express an opinion on the financial report based on our audit. We have conducted our audit in accordance with the Australian Auditing Standards. Those Auditing Standards require that we comply with the relevant ethical requirements relating the audit engagements and plan and perform the audit to obtain reasonable assurance whether the financial report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about amounts and disclosures in the financial report. The procedures selected depend on the auditor's judgement including the assessment of the risks of material misstatement of the financial report, wether due to fraud or error. In making those assessments, the auditor considers internal control relevant to the association's preparation and fair presentation of the financial report that gives a true and fair view, in order to design audit procedures that are appropriate in the circumstances, but nor for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An Audit also includes evaluating the appropriateness of accounting estimates made by presentation of the financial report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Opinion

In our opinion, financial report gives a true and fair view of the financial position of Cerebral Palsy Support Network Inc. As at 30 June 2012 and its financial performance for the year then ended in accordance with the accounting policies, and the Associations Incorporation Act 1981 (Vic).
